WHY DEVS LOVE SONIC

- Ethereum Bridge: EVM compatibility lets Ethereum devs migrate seamlessly, slashing costs.
- 90% Fee Monetization: Devs earn 90% of transaction fees—\$9K daily on a \$10K dApp—fueling long-term innovation. Compared to 0%-30% on other chains, why would they go anywhere else?
- Sonic Airdrop: Distributes 200m S tokens starting June 2025, rewarding users (via Points) and developers (via Gems) with a vesting and burn mechanism to balance supply and engagement.
- Fee Monetization: Offers developers up to 90% of app-generated fees, creating a sustainable income model and encouraging ecosystem growth.


